The Band Designate Representative (BDR) provides quality and accountable support services to children and families of Saik'uz First Nation (the Nation) involved with the Ministry of Children & Family Development (MCFD), the judicial processes under the Family Law Act, or any other applicable child welfare legislation. The BDR seeks to address the needs of community members and achieve a pathway toward restorative policy and practice that supports and honours Dakelh cultural systems of caring and resiliency.

Duties & Responsibilities:

- Develop and deploy prevention and intervention strategies and community programming based on demonstrated need.
- Comply with local, provincial, and federal government laws, standards, and regulations.
- Represent the Nation in a variety of capacities, such as:
 - o in court as a Party to Child Welfare proceedings
 - o liaising with other First Nations' BDRs, agencies, and legal counsel
 - o accompanying MCFD workers during investigations
 - supporting the Carrier Sekani Family Services (CSFS) Family Preservation and Community Wellness teams
- Advocate for individuals and families to ensure their rights and the holistic best interests of the child(ren) are upheld.
- Ensure band members are fully aware of their rights.
- Provide case evaluation and development.
- Support the revitalization of the Nation's language, governance structure, and belief systems.
- Perform clerical and administrative work necessary to the position.
- Other duties as required by the Health Manager or General Manager.

Qualification Requirements:

- Post-secondary education or Social Work Diploma and/or Legal Services Diploma
- Valid driver's licence and a reliable vehicle

- Criminal Record Check
- Experience working with First Nation people
 - o Experience specific to working in the social services field an asset
- Experience working with children and families
- Willing to work flexible hours and travel with minimal notice
