Councillor Jackie Thomas

Introduction and Updates

RTA

- Jackie Thomas, Saik'uz First Nation, David Luggi, Stellat'en and Bev Ketlo have worked on this.
- Melinda Skeels will be joining this afternoon to provide a more detailed legal update --awaiting a verdict for Christmas.
- Lead Executive visited in June 2022 and organized a visit to the territories (Stellat'en, Saik'uz and Nadleh)
 - Showcase and understand what the concerns are of the nations.
- Additional meetings were had with the Australian Indigenous groups to navigate the fight against a multinational corporation and to ensure we are not lowering our standards.
 - The 70-year-old situation we are trying to fish

Fishery Council

- Involvement around water governance and involved with water work since 2014.
- Work focused to ensure policy regulations and governance concerns involve the first nation and our rights
- Water is life, it can give and take life away
- Our focus is for both people and animals, moving forward and having BC Official onboard to continue moving forth; Canada is not onboard, but due to change over of staff in office we have been a setback.
- Upcoming meeting with Chiefs and the minister to review this problem and hopefully meet in person.
- We want to have our representation and our voices of what are the problems and solutions.
- Stewardship and Restoration Initiatives meeting held and more engagement moving forth

- Ensure that not only salmon, but other species can continue to live and survive
- We had a preliminary pilot study done to gather baseline information; no prior data exist in this area and information.
- This information will help us in the future and gives us knowledge on how to move forth; What our member want to see and continued engagement.

Proposal: A New Multilateral Agreement to Replace the 1987 Settlement Agreement

- New government-to-government governance regime, including an adaptive comanagement framework for the Nechako watershed and Reservoir; coupled with a robust engagement process with, and co-developed by, local governments and stakeholders.
- 2. Stepwise implementation of an Environmental Flow to partially restore the health of the Nechako River and recover the sturgeon and salmon populations.
- 3. Modify EPA between RTA and BC Hydro to eliminate required surplus energy sales to BC Hydro. BC provides low-cost replacement energy to keep Rio Tinto's smelter operating at 100%.
- 4. Ongoing litigation is settled and Rio Tinto and NFNs release BC and Canada from future claims. NFNs provide legal and operational certainty to Rio Tinto's operations.
- 5. BC and Canada provide economic stimulus resources for infrastructure projects to implement an Environmental Flow, and funding for culture, food security, land use, stewardship, etc.
- Refer Section 3
 - The agreement expires in 2024 but wants to make changes so that the water flows towards us and not the river.
- Refer Section 4
 - Other court cases and other nations that can use this case as a reference
- Refer Section 5
 - Assessment on an Infrastructure project, Food security hasn't been discussed and Land use currently we feel the Province of BC regarding this, Kasandra Turbide elaborates further.
- It has taken over 1900 hours on this file, and to continue moving forth, difficulty with moving to solution-focused solutions for all parties.

Benefits of a New Multilateral Agreement

- BC takes a very significant step in advancing reconciliation with the NFNs, resolving a 70+ year old historical grievance.
- 2. BC and NFNs implement *DRIPA* together, by including the NFNs in the governance of the watershed and Reservoir.
- 3. The health of the Nechako River is partially restored, and sturgeon and salmon populations recover.
- 4. NFNs resume exercising their Aboriginal title and rights, and all citizens benefit from increasing sturgeon and salmon populations.
- 5. All parties achieve legal certainty in connection with Rio Tinto's BC works.
- 6. BC Hydro ratepayers avoid expensive power purchases, and BC Hydro surplus power is deployed to save the Nechako River.
- 7. Smelter continues to operate at 100% capacity, providing jobs, tax revenue, and profits.
- 8. Economic stimulus from construction of infrastructure and stewardship projects to implement an Environmental Flow.
- Wet'suwet'en and newly joined table Cheslatta regarding the Kenny Dam Facility, and the Flooding of burial ground being washed away in Cheslatta.

Industry Updates

Barry Vickers

 Works are an advisor for the Nation and have worked on the following projects: Blackwater Mine, CGL, Economic Development, and Forestry File.

Coastal Gas Link

- Saik'uz signed an impact benefits agreement with Coastal Gas Link Pipelines LTD.
 - o Includes financial, employment and procurement opportunities.
- Link runs approx. 30 km of Saik'uz Territory
- The Project is 50% complete and most construction activities on or near Saik'uz Traditional Lands have been completed.

- Saik'uz has received contracts for Right of way clearing, and catering for the camp; 50% more occupancy than was originally expected.
- Saik'uz will have the option to also purchase a potion of equity ownership in the pipeline.

Lhai Ventures Limited Partnership

- Nations involved: Saik'uz, Stellat'en, Nadleh, and Lheidli Tenneh to work together to secure the procurement/ contract opportunities connected to the CGL Project.
- Lhai Ventures has grievances with CGL on the process and amounts of contracts awarded to the four nations. Lhai is asking that CGL compensate Lhai Ventures for the lack of contracts it has been awarded.
 - Many of these opportunities are being awarded to out-of-province contractors/ works over members of the nations.
- Ms Regina Toth is the General Manager and member of the Lheidli Tenneh First nations, whom I provide advisory assistance with oversight of Lhai Ventures
 - o Lhai Nations was originally set up to pursue a contract on the CGL Project.
 - Contracts to wrap up in the Summer of 2022
- Saik'uz along with the other Nation will have to determine if there are other projects or initiatives to pursue in the future.

Forestry Strategy

- Assisting in the development of a Forestry Strategy and reviewing the current relationship we have with Canfor; cease harvesting until we can both reach an agreement.
- The documentary "Nechako" has been part of our strategy to relay the Nations message regarding sustainable harvesting and the need to get consent from Saik'uz for future harvesting in the territory
- Canfor heading into approx. 3 logging seasons without them harvesting on our territory.

Blackwater Mine

- Australian-based company Artemis Gold purchased New Gold.
- Working on securing contracting opportunities for the three-member Nations in the electrical Transmission Line that will power the mine.
- The Nations in partnerships with a company called Carisbrooke won the bid with construction to commence in Feb 2022.
- Working on securing subcontracts to provide road maintenance, bussing, transmission line right of way, maintenance, and environmental services. Many of their contracts span 20+ years (lifespan of the mine).
- Supports the impact of the benefits Agreement with Artemis Gold
 - o Negotiating ownership of the transmission line
- Support for the three Nations on engagement with two southern nations that are impacted by the mine and hoping to come to a collaborative approach in securing contracts.

Saik'uz Economic Development

- Work has included analysis and works on plans to develop the Noonla Indian Reserve
 including an addition to the reserve, agricultural land reserve constraints as well as a land
 designation that would enable the band to potentially lease lands for development.
- Advise and assistance on real estate purchases such as Tatuk Lake Resort
 - o On 20 acres of land with 660 feet of lake frontage.
 - o Primary living dwellings, cabins, outbuilding etc.
 - Would offer right and title value to Saik'uz
 - o Potential business opportunity
- Will continue working with Jason Alexis in managing Economic Development priorities for the band and provide advice to leadership for new ventures.

Economic Development

Kasandra update on behalf of Jason Alexis

Networking and Skill Development

 Maintaining positive relationships with local businesses, industry, corporations and government workers and officials.

Internal Operations

- Review, evaluate, and audit our internal projects and programs that economic development oversees or assists with.
- Saik'uz First Nation has several business interests that include a variety of forestry activities, mining, catering, and short- and long-term leasing.
- Saik'uz also attempts to promote and assist the development of membership entrepreneurs that operate within our territory.
 - o artwork, leatherwork, crafts, silviculture, security, and a variety of service industry work. Economic development is routinely required to utilize contacts to advance capital and service projects. It is also a requirement to research and assist in reporting economic development opportunities of which two involve property acquisition.
- Members can contact Jason Alexis if they have any questions.

Coastal Gaslink Project

- The Coastal GasLink (CGL) project is a long-term development of the management and advocacy of Saik'uz interests.
- SA Energy Group and Pacific Atlantic Pipeline Construction Incorporated are the two CGL prime contractors which operate within Saik'uz Territory.
 - Within the project, Saik'uz formed a partnership with Lheidli T'enneh, Nadleh, and Stellat'en.
 - The four nations formed Lhai Ventures and are pursuing partners to attain any subcontracts and employment opportunities that may arrive from the project.
 - We have had over fifty community members employed in the project.
 - o PAPC as the section that they are working on is earlier in its construction phase.
 - Saik'uz membership to contact me for employment and training currently available from the project.

Agreement Management

- Saik'uz First Nation has many past, present, and pending agreements with companies, organizations, and provincial and federal governments.
- It is necessary to become familiar with our current agreements so deviation from the agreements may be addressed.
 - Ensure employment and financial obligations outlined for the nation or individual band members to capitalize on are adhered to.

Committee

Currently, sitting on six committees which meet quarterly or as required.

Special Projects

- Multiple ongoing projects centred around services, infrastructure, and governance of Saik'uz First Nation.
- These projects can be partially or fully funded by Indigenous Services Canada (ISC). Projects not funded, or partially funded require the nation to cover.
 - Search for grants and proposals, and subsequent responsibilities such as reporting and management of these funds.
- Project resuming post-Covid-19 restrictions are:
 - o The Fire Smart Program, an updated Saik'uz First Nation Emergency Plan

- o Saik'uz First Nation Comprehensive Community Plan
- Designation of IR # 6 Noonla.
 - The designation does not include Lot 4; certificate of possession designation.
 - The designation is required for leasing reserve land, requires an environmental assessment, appraisal, and a community referendum and is replacing a previous designation that was instituted for the Dezti Specialty Wood Products Building.

Land & Resources Manager

Kasandra Turbide

Introductions

- Overseeing staff, and administration functions, initiatives, and industry meeting stewardship projects in Saik'uz Keyoh.
- Cora McIntosh hired as Assistant Land & Resources Manager
- Environmental stewardship Government Updates
 - o Dec 19, 2022, 11 major licenses signed a new agreement: in the PG timber supply areas and implementation of the "Immediate Measures:

Immediate Measures:

- Speed of Avoidance of management of biodiversity
- In-block Retention
- Reparation management
- Moose Management
- Working with the province for immediate measures, as the voluntary collaboration with the licenses did not yield results.
- Working on resources management to determine what these areas look like in Saik'uz Territory.

TGOC

- Pilot project for restoration ecosystem restoration plan, which was delivered to households.
- Allows members from the families to provide input.

CGL Committee

- We meet bi-annually to discuss issues as well as review the agreements that are being honoured.
- Harold Alexis is the community construction liaison, he monitors the pipeline and submits reports to L&R

Blackwater Goldmine

- Working on negotiation with the company for our project agreement, which includes Nadleh and Stellat'en.
- Input on plans and permits and the effects.
- Water monitoring project works will be done as Cllr Jackie Thomas spoke one.
- Ashley Raphael works on behalf of Nadleh and Saik'uz since 2018. In her position, she addresses concerns around resources management.
- She attends various inspections and is integral to the water monitoring, currently taking training on a new water program Aquarius.

Cora McIntosh, Assistant Land & Resources Manager

- Onboarded in 2021 and working on referrals and permits, land-based work intended to take place anywhere in the territory for our review, recommendations etc.
- Anytime there is going to be work done on land, we need to do an archaeological review to
 ensure that we protect areas that may have the information we require.

 UNBC BA Planning Degree will be wrapping up and graduating in December 2021, and excited to have the opportunity to do this work for the community.

Old Growth, New Beginnings Screening

Ratcliff Update

Melinda Skeels

Introductions

- Acknowledgement, and will be providing an update of the trial wrap-up in July 2021
- 2011 The Court Claim was brought forth, and when the court case was initially filed on behalf of Stellat'en and Saik'uz in form of Tort
 - A tort is a civil wrong that causes a claimant to suffer loss or harm, resulting in legal liability for the person who commits the tortious act.
 - Nuisance claims or reparations rights were also brought forth, proving ownership of the lands.
 - We based our claim on Rights and Title instead.
 - Alcan filed to the judge arguing that there was no legal backing to provide rights and title, and at the time in 2015.
- Alcan then had the province join this lawsuit and it took 4 years to be able to finally go to the courts.
- Examination for discovery and witnesses officially kicked off Oct 2019 we received a trial date after 189 court days we finished, on July 19, 2021.
 - \$118,000.00, documents in litigation, 785 exhibits in trial, 40 local witnesses, 20 expert witnesses (eco, fish biology etc.)
 - o Jackie Thomas, Hazel Alexis, Betsy William, Gerry Mole, and Gladys Michell all provided testimony.
- Lawyers asked the Court to find that they had constitutionally protected Aboriginal rights to fish in the Nechako River and its tributaries.
 - The construction and operation of the Kenney Dam were interfering with those rights by causing harm to sturgeon and salmon in the Nechako watershed.
 - Recognize that interference as a private nuisance, and order RTA to release more water into the river to prevent further harm to fish.

Remedy

- We are not seeking money but to reduce the damage:
 - Option 1 remove Kenney Dam
 - Option 2 restore functional flows to return to a more natural state increasing natural water flow and controlling the temperature

Closing

 Expect that there will likely be no decision made due to the extent of information and documents presented.




Revenue - 2021 vs. 2020

Chief Mueller

- Saik'uz is dealing with concerns in the community before covid we started a task form, as well as looking at implementing a drug strategy to move forward.
- Currently, we are focused on getting treatment for those seeking support; shortages and long wait times to get into treatment centres.
- We know that our members are affected by addictions, and we are trying to address and navigate alongside the RCMP.
- It will require community support to tackle these issues, we have members hiding.

Cllr Jasmine Thomas

- Working on addressing these issues, and we know covid has added more strain compounding these issues.
- We also have the challenge to address these in a criminal sense by engaging with the RCMP
- Social Issues are the second part
 - o It's a complex issue and we are also moving closer to having a northern centre that will be open to all the CSFS.
 - Child and Family Health prevention money has been awarded for this tied to kids in care
 - o Chief Mueller returned from meetings with the minister to advocate for funds.

Cllr Teed

- A sensitive subject can be a family member, and I find it difficult when we have had to evict members, as well as my personal family experiences.
- I speak with the RCMP and how things used to be, those leaders in the community that acted
 as enforcement our current members we need to step up and look after our own families.
- When I struggle, I think back to how our history and elders found the answers.

Cllr Jackie Thomas

- I'm an adult child of substance in my household
- Our children are growing up different, and faster, and external influences are more prominent in our youth.
- The issues are not just here, and they can't be solved just by the Chief & Council, it requires
- We have all these funds, and monies coming in and having been in poverty and all these
 extra monies are increasing these issues due to not having the financial management
 knowledge.
- I think about grandma's words:
 - o I pity the future generation, they are going to have a tough time if they make it, they are going to have to be strong people
- We can't force people to change, and you can only cross that road when you are ready. Our family can help support us.
- I encourage you to be a support to your friends and families.

Constable Gohn

- I've been working to implement a drug strategy and address these issues, but it does require community support.
- We hope to reinstate the PeaceKeepers.
- I'm available in the office, or through the Vanderhoof RCMP
- For our Youth, I believe that part of this issue needs to start with the younger generations, at the schools and also in the community.
- This is a nationwide issue and it's a difficult one to navigate, and I think that coming together and doing engagement in the community can help set a path forward.
- We are looking at both traditional means and the justice western model to create connections for resources.


